SHELTER, BEHAVIOR & TRAINING: THIS PROGRAM PROVIDES SHELTER AND CARE FOR HOMELESS ANIMALS, ADOPTION SERVICES, LOST AND FOUND PET SERVICES, HUMANE EUTHANASIA OF SICK OR AGGRESSIVE ANIMALS, BEHAVIOR MODIFICATION FOR SHELTER ANIMALS AND PET TRAINING TO THE PUBLIC, AND COORDINATION OF VOLUNTEERS.

IN 2015, OUR SHELTER HAD 7,042 INCOMING COMPANION ANIMALS, INCLUDING 136 OWNER/GUARDIAN REQUESTED EUTHANASIA. WE ADOPTED 5,218 PETS TO NEW HOMES, AND 1,083 PETS WERE RECLAIMED BY THEIR OWNER/GUARDIAN. OUR LIVE RELEASE RATE WAS 93%.

IN 2015, OUR VETERINARY CLINIC PEFORMED 3,416 SPAY AND NEUTER SURGERIES AND SAW 10,840 APPOINTMENTS, INCLUDING 1,173 LOWER INCOME CLIENTS RECEIVING A SHARE PROGRAM DISCOUNT.
