SHELTER, BEHAVIOR & TRAINING: THIS PROGRAM PROVIDES SHELTER AND CARE FOR HOMELESS ANIMALS, ADOPTION SERVICES, LOST AND FOUND PET SERVICES, HUMANE EUTHANASIA OF SICK OR AGGRESSIVE ANIMALS, BEHAVIOR MODIFICATION FOR SHELTER ANIMALS AND PET TRAINING TO THE PUBLIC, AND COORDINATION OF VOLUNTEERS. IN 2017, OUR SHELTER HAD 6,784 INCOMING COMPANION ANIMALS, INCLUDING 132 OWNER/GUARDIAN REQUESTED EUTHANASIA. WE ADOPTED 5,087 PETS TO NEW HOMES, AND 1,088 PETS WERE RECLAIMED BY THEIR OWNER/GUARDIAN. OUR LIVE RELEASE RATE WAS 94%. OUR TRAINING AND BEHAVIOR DEPARTMENT SERVED 3,124 CLIENTS TAKING A TRAINING CLASS OR PRIVATE CONSULTATION. THE DEPARTMENT REHABILITATED 815 DOGS AND CATS THROUGH ITS BEHAVIOR MODIFICATION PROGRAM.

WE PROVIDE SUBSIDIZED VETERINARY CARE TO THE PUBLIC ON AN INCOME BASED DISCOUNT PROGRAM. IN 2017, OUR VETERINARY CLINIC PEFORMED 3,790 SPAY AND NEUTER SURGERIES AND SAW 11,084 APPOINTMENTS, INCLUDING 1,165 LOWER INCOME CLIENTS RECEIVING A SHARE PROGRAM DISCOUNT.
